

Until Further Notice:

YELLOW ACTION LEVEL MANDATORY WATER USE RESTRICTIONS:

- A. Outdoor watering or irrigation of lawns is prohibited.
- B. Outdoor watering of any kind is prohibited between the hours of 8:00 a.m. and 8:00 p.m. daily.
- C. Water or irrigation of flower and vegetable gardens, trees and shrubs less than 4 years old, and new seeding or sod is permitted once per week with an application not to exceed one inch.
- D. **Car washing is prohibited** except in commercial establishments that provide that service.
In these cases, hours of use will be restricted to 8:00 am to 8:00 PM.
- E. ***No water shall be used to fill private/residential swimming pools, children's wading pools, reflecting pools, or any other outdoor pool or pond.***
- F. No water shall be used to wash streets, parking lots, driveways, sidewalks, or building exteriors.
- G. **Large volume water users, including industries, motels, hotels, and eating establishments may be requested to scale back services.**
- H. Schools will be required to cancel their physical education activities and inter-scholastic competitions that require showers or attract crowds and take other actions to reduce water consumption at sport complex.
- I. Water shall be served at restaurants only upon the request of the customer.

Water reclaimed or recycled after some primary use, such as water that has been used for washing or cooling, may be used without restriction. Additionally, water derived from other sources other than the city water utility, such as water condensed from the atmosphere by air conditioners or collected from rain or snow, may be used without restriction.



Annual Spring Clean Up Day

Friday, April 25

All non-appliance items must be contained in garbage bags or receptacles. Loosely piled garbage constitutes a NUISANCE and will result in a minimum \$85 CODE VIOLATION FEE.

Citizens will be responsible for purchasing large item stickers that must be placed on appliances in order for them to be removed during the clean-up day.

Large item stickers are currently available for purchase at City Hall.

Large item stickers cost \$30.00 and are required for appliances to be removed.





YOU'RE A GRAND OLD FLAG PROGRAM



Avoca Fire & Rescue Association offers the community to show their national pride with a subscription to our **You're A Grand Old Flag Program** for only **\$50** per year. Avoca Fire & Rescue Association members will place a 3'x5' nylon American Flag on a 10' pole in your front yard on six of our national holidays. Memorial Day, Flag Day, Independence Day, Labor Day, Patriot Day and Veterans Day.

Avoca Fire & Rescue Association will post the Flags at dawn and retrieve them at dusk. The Flags may stay up all weekend on a three-day holiday weekend. A receptacle that will remain in place for the year will be installed 2'-3' from the back of the curb in the center of your property. It will be flush with the ground, so it will not interfere with mowing.

Inside The Home

-  Test your home's smoke and carbon monoxide alarms.
-  Don't use electrical appliances with frayed cords.
-  Check for water around electrical appliances.
-  Clean debris from your clothes dryer lint trap and exhaust duct.

Outside The Home

-  Remove dead leaves and other debris around foundations, decks, porches, and stairs.
-  Check grills for rust, worn parts, insects, grease, and other debris before use.
-  Grills should only be used when at least 10 feet away from your house or any building.



**NO LEAVES, GRASS, or Other DEBRIS
allowed in Streets or Alley Ways!**

DO NOT MOW OR BLOW INTO STREETS!

IT IS AGAINST OUR CITY ORDINANCE TO DO SO.

Violators will be ticketed.

PROPERTY OWNERS will be notified for code violation regarding the height of grass 6 inches and taller. When not brought into compliance, the City will mow and a penalty fee will be charged to the property owner.

IF OUR CITY WATER TOWER COULD TALK:

"Help me do my job!"

"My water level is nearly at the RED ZONE! If that happens you will need to boil water – AND residential water will be limited.

All water use will be limited to human consumption, sanitation, and public safety. This will affect AHSTW Schools, local industry and businesses.

Any nonessential water use during "Action Level Red" will be strictly prohibited and subject to penalties.



PET LICENSES ARE OVERDUE

Starting on March 1st there is a \$5 fee placed on each pet for each month that it is not licensed on time. Now that it is April, the fee total is \$10 per animal.

AT THIS TIME, Pott. County Animal Control has been notified of all owners who have not licensed their pet(s) per the violation of City Code.

If your pet is no longer living with you or you have suffered the loss of your pet, please notify us and we will remove you from our records.

Grant Applications Now Open to Boost Main Street Iowa Businesses

Small businesses located within Avoca Main Street and other designated Main Street Iowa districts are invited to compete for up to \$25,000.

Main Street Iowa's annual Open 4 Business program supports existing businesses and revitalization in the more than 50 Main Street Iowa communities. For the contest, entrepreneurs will outline a business development or expansion idea, such as additional services and product offerings or needed equipment.

Eligible businesses are for-profit and have been operating at least one year in a Main Street district. In addition to the online application, applicants also must submit a short video highlighting their business project and how it will benefit their community's economic climate. A 25% cash match is required.

Only one application is allowed per Main Street community. To determine which local business will represent Avoca, turn in a video submission to [main-](mailto:mainstreet@cityofavoca.com)

street@cityofavoca.com by April 7, 2025.

State competition applications must be submitted through the local program to Main Street Iowa by May 1. Main Street Iowa staff will review them for project impact within the designated Main Street district; business innovation; and opportunity for continued growth, enhanced revenue and sustainability. Five finalists will advance to the state competition on Aug. 4 in Muscatine, where they will pitch their expansion ideas before a panel of judges.

Open 4 Business launched in 2015 and over the past decade has awarded dollars to over 50 businesses across the state. Grants are administered through the Iowa Economic Development Authority's (IEDA) Iowa Downtown Resource Center and Main Street Iowa programs.
